Leadership Challenges in Global Health Informatics (PBHL H763)

2019-2021; 2023-Present (Summer Session)

This online course provides DrPH students with insights into timely issues relating to global health informatics. The course helps students understand current global challenges and opportunities in health informatics and equips them with the skills and knowledge they need to effectively identify and address information needs in organizations.

Information Exchange for Population Health (PBHL-E645 & AMIA 10x10) 2015-Present (Summer Session)

This online course explores the electronic exchange of data, information and knowledge between clinical and public health organizations in support of population health. Students will examine the strategic, organizational, legal, technical, and socio-political aspects of clinical and public health information exchange in the United States and abroad.

Note: In 2022 an Adjunct Instructor taught the course using my materials while on sabbatical.

Foundations of Public Health Informatics (PBHL-E635)

2015-Present (Spring Semester)

This online course introduces the field of informatics to public health students. Core aspects of informatics relevant to the collection, management, and application of public health data will be reviewed. Examples are drawn from core public health functions, such as vital records, surveillance, immunization, environmental health, and community health assessment.

Note: In 2022 and 2023 an Adjunct Instructor taught the course using my materials while on sabbatical.

#### Previous Courses

Public Health Informatics (PBHL E400)

2021 (Spring Semester)

This course is designed to introduce the student to recent and ever-expanding area of public health informatics. First, fundamental concepts of informatics, health information exchanges, and common data sources for public health informatics will be presented. The remainder of the course draws on these concepts to examine the use of these in public health. Throughout this course, students will learn how data can be collected from varying sources and used in public health.

Doctoral Research Seminar in Epidemiology (PBHL-E775)

Summer 2016

This course is designed to expose PhD students to a wide range of specific research topics and issues in Public Health. The seminar topics will be chosen by the Director of the PhD program and the Course Director with input from other faculty members. The PhD students are expected to attend each seminar session, read assigned material, and participate in the seminar discussions. The PhD students may be asked to present their research projects during the seminar to obtain feedback and recommendations from the faculty and other students.

Clinical Decision Support Systems (INFO-B642) Spring 2014

This course provides an in-depth review of the history, science, practice, and state-of-the-art research on Clinical Decision Support Systems (CDSS). Topics include: design principles behind CDSS, architecture and integration of CDSS, implementation and adoption of CDSS, knowledge management, mathematical foundations of knowledge-based and pattern recognition systems, legal and ethical issues, patient centered CDSS, population level CDSS, and the application of CDSS in a variety of contexts.

Health Information Exchange (INFO-B582) 2013-2014

This course offers an in-depth review of health information exchange (HIE), the electronic exchange of administrative and clinical information between disparate health care organizations. Students will examine the strategic, organizational, legal, technical, and socio-political aspects of HIE initiatives. Students will further review the evidence on the impact of HIE services on health care quality, safety, efficiency, and cost.

Seminar in Health Informatics I (INFO-B667)

2012-2013 (Fall Semester)

The course provides graduate students with knowledge on a wide range of advanced topics in biomedical informatics. Themes: Human-computer interaction and usability of clinical information systems (2012-2013); Development and interoperability of information systems (2011)

Seminar in Health Informatics II (INFO-I668) 2012-2013 (Spring Semester) The course provides graduate students with knowledge on a wide range of advanced topics in biomedical informatics. Themes: Clinical decision support (2013); Big medical data and health care analytics (2012)

# **Course Development**

Public Health Informatics (PBHL-E400) - Course Design (2019)

Course introduces students to the exciting discipline of public health informatics to undergraduate students, especially epidemiology majors and other public health students.

Public Health Surveillance (PBHL-E391) – Course Design (2019) Surveillance is the cornerstone of public health practice. In this course, students explore the past, present and future of public health surveillance in the context of the U.S. and international health regulations.

Introduction to Population Health Analytics (PBHL-E647) – Course Design (2018)

This course examines the use of analytics and big data in the context of population health within governmental public health agencies as well as health systems. Students will be introduced to a host of methods used to analyze population health data, and gain technical skills required to perform analytics in support of real-world use cases. Practical demonstrations will be covered using Weka software, as well as python and R programming languages.

Information Exchange for Population Health (PBHL-E645) – Course Design (2015) This course is designed to introduce MPH and MHA students to the concepts of electronic data exchange for population health contexts within both clinical and public health settings.

Foundations of Public Health Informatics (PBHL-E635) – Course Redesign (2014) This course introduces public health informatics, especially designed for MPH and MHA students. Emphasis is on foundational informatics building blocks to support public health practice.

Clinical Decision Support Systems (INFO-B642) - Course Redesign (2014)

Previous instructor did <u>not</u> provide materials. Course covered both the theory and application of CDS systems in modern health care. The course syllabus was organized into three sections: introduction and theory; existing CDS applications; emerging CDS paradigms.

Health Information Exchange (INFO-I582) - Course Redesign (2012)

Previous instructor provided materials. I restructured the syllabus to organize the course around key domains pertinent to the exchange of clinical data across institutional boundaries. In addition, I enhanced the content and assignments to include more technical knowledge of HIE information systems and modules. I further enhanced the reading list and lecture materials with papers and knowledge from my own research in HIE.
