



2015 Workplace Health & Wellness Survey Indiana University-Purdue University Columbus

Introduction

Indiana University-Purdue University Columbus (IUPUC) is the smallest IU campus location, with just over 100 full-time employees located there. Overall, **28%** of IUPUC employees participated in the IU Workplace Health & Wellness Survey implemented between 4/6 and 5/18/2015 among all full-time employees of IU's eight campus locations statewide.

*Current record-keeping practices include IUPUC within the IUPUI employee numbers. As a result, IUPUC-specific demographic information is currently unavailable.

The results shared below are based on responses from full-time employees who identified themselves as being affiliated with the Columbus campus. However, these results have been weighted to match the demographics of the IUPUI employee population, because IUPUC, administratively, is considered a part of IUPUI. These results are not suitable for comparison with results from other campuses.

Health in General

In response to questions regarding physical and mental health in general, IUPUC employees responded as follows:

- **88%** rate their *health* as good, very good, or excellent.
- **41%** of employees reported having days in the past month when their *physical health* was not good.
 - Of employees reporting poor physical health in the past month, the average number of days was **5**.
 - Across all employees, the average number of poor physical health days in the past month was **2**.
- **45%** of employees reported having days in the past month when their *mental health* was not good.
 - Of employees reporting poor mental health in the past month, the average number of days was **13**.
 - Across all employees, the average number of poor mental health days in the past month was **5**.

In response to questions assessing employee perceptions of general support for health and safety within the workplace environment, IUPUC employees responded as follows:

- **68%** consider *the university* to be supportive of their personal health (rated 7-10 on 1-10 scale).
- **61%** agree/strongly agree that *management* considers workplace health and safety to be important.
- **68%** agree/strongly agree that their *supervisor* is concerned about the welfare of those under him/her.
- **63%** agree/strongly agree that *coworkers* support their efforts to be healthy.






Campus to Community Context

IUPUC employees belong to both a greater community of IU employees across the state and the varied communities in which they live. IU employees influence - and are influenced by - their work and residential environments. How do the employees of IUPUC compare to employees of IU overall or to adults across the state of Indiana? Below we have shown for context the comparable values for some key health measures included in our survey. Please note that the state data are based upon the 2014 Behavioral Risk Factor Surveillance Survey, whereas the IU Workplace Health & Wellbeing Survey was conducted in early 2015.

All three of these health measures are generally associated with an educational gradient; the higher the education level, the better the health measure. For example, in 2014 the smoking rate among Indiana adults with less than a high school education was 39.6%, but only 7.4% among college graduates. Since the IU employee population is, on the whole, highly educated, with more than 75% of 2015 respondents having a college degree or more, we expect to have lower rates of poor health, smoking, and obesity than reported for Indiana adults in general.

In comparison to IU overall, the employees of IUPUC:

- Have a **slightly higher/worse** percentage who rate their health as fair or poor;
- Have a **similar** rate of smoking;
- Have a **higher/worse** rate of obesity.

In comparison to adults across the state of Indiana, the employees of IUPUC:

- Have a **much lower/better** percentage who rate their health as fair or poor;
- Have a **much lower/better** smoking rate;
- Have a **slightly higher/worse** rate of obesity.
